

RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

Express Assumption of Risk Associated with Mechanical Bull Riding and Use of Inflatable Equipment:

I hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with mechanical bull riding activities and/or use of inflatable equipment in which I am about to engage, including but not limited to:

- The rotation and bucking movement of the mechanical bull which will cause me to fall off of the bull in an uncontrollable manner;
- The changing condition of the equipment used during bull riding, the ground surface, and the speed and movement of the bull;
- Movement of inflatable equipment and actions of other individuals simultaneously using inflatable equipment;
- My sense of balance, physical condition, ability to use inflatable equipment, ride and hold on to the mechanical bull or follow directions;
- Possible equipment failure or malfunction of my own or other's equipment; and
- My own negligence or the negligence of another, including employees, agents, independent contractors or representatives of Georgy's Raging Bull and Inflatables including but not limited to operator error.
- Dependent upon a person's physical condition, age and skill level, riding a mechanical bull or using inflatable equipment can involve a substantial risk of various injuries, including but not limited to: heart attack, stroke and circulatory problems, bone and joint injuries, back injury, muscle strain, nerve damage, injuries to back and any other illness or soreness.
- I understand that I am participating at my own risk and affirm that I am in good physical condition, I am not pregnant and do not suffer from any known disability or medical condition which would increase my chances of injury. My participation is purely voluntary and I elect to participate in spite of the risks.
- *I understand the risks associated with the activity cannot be eliminated without eliminating the essential qualities of the activity.*

Release of Liability, Waiver of Claims, and Indemnity Agreement:

In exchange for my rental, I agree to waive and relinquish any and all claims that I may have as a result of participating in this recreation against Georgy's Raging Bull and Inflatables, its agents or employees that might be directly or indirectly liable for any injuries sustained during participation. As such, I acknowledge and agree that neither Georgy's Raging Bull and Inflatables, nor any of its agents or employees, are responsible for any cost, damage to personal property, loss of property, bodily injury, sickness, or accidental death as a result of my use of any inflatable equipment and/or riding or attempting to ride a mechanical bull. I hereby release and discharge Georgy's Raging Bull and Inflatables and its agents from any and all losses, claims, suits, demands, and causes of action as a result of my voluntary participation.

By signing this Agreement, I am not relying on any oral or written representation or statements made by the releases, other than what is set forth in this Agreement. I assume full responsibility for my risk of bodily injury, death or property damages while riding or attempting to ride this mechanical bull or using inflatable equipment.

I hereby declare that I am of legal age and am competent to sign this Agreement and do so freely and voluntarily. I have read this Agreement, understand it, and I agree to be bound by it.

I UNDERSTAND THAT I MAY CHOOSE NOT TO PARTICIPATE IN THIS ACTIVITY IF I DO NOT UNDERSTAND THIS DOCUMENT OR DO NOT WISH TO WAIVE MY RIGHTS OR ASSUME THE RISKS STATED HEREIN.

Rental Agreement

PLEASE READ THOROUGHLY. It is the responsibility of the person or organization hiring Georgy's Raging Bull and Inflatables to ensure that all possible precautions are taken to avoid injury to people or damage to property of Georgy's Raging Bull and Inflatables. (Please note that the term "unit" used below refers to any inflatable, mechanical bull or other property rented from Georgy's Raging Bull and Inflatables) **Please ensure that the following safety instructions are followed:**

- 1) The number of children using the unit will be limited according to age, size, and manufacturer's recommendations.
- 2) Absolutely NO food, drink or chewing gum on or around the unit.
- 3) Shoes, glasses, jewelry, and badges MUST be removed before entering the unit.
- 4) No pets, toys, or sharp instruments on the unit at any time.
- 5) No face paints, party poppers, streamers, or silly string to be used in or near unit.
- 6) No smoking in or around the unit
- 7) No climbing, hanging or sitting on walls or roof of the unit.
- 8) Precautions must be taken to avoid children tracking mud or grass into the unit.
- 9) Children are not to push, collide, fight or behave in a manner likely to injure themselves or others.
- 10) No one is to be on the inflatable equipment during inflation or deflation. If the inflatable begins to deflate when in use, everyone must stay calm and exit the unit immediately.
- 11) No moving of equipment allowed unless by staff of Georgy's Raging Bull and Inflatables.
- 12) Water hoses and water cannot be used on the unit unless it is specifically rented as a water unit (water slide or dunk tank).
- 13) If winds exceed 15-20 mph, there is heavy rain, or there is lightning the unit must be evacuated and turned off until the weather subsides.
- 14) **THE MOST IMPORTANT RULE: ADULT SUPERVISION IS REQUIRED AT ALL TIMES.**

FINES: Customer is responsible for returning the unit in the same condition in which it was received. We reserve the right to assess a fine of \$75 for each hour spent cleaning the unit. The cost of any physical damages will also be charged to customer.

3. No pets allowed.
4. NO SILLY STRING, face paint, party poppers or streamers in or around unit.
5. No smoking in around unit.
6. No climbing, hanging or sitting on walls or roof of unit.
7. Avoid tracking mud, sand or grass onto unit.
8. No one is allow on equipment during inflation or deflation. If unit begins to deflate while in use, stay calm and exit the unit immediately.
9. No moving equipment unless by staff of Georgy's Raging Bull.
10. No water allowed unless unit is specifically rented as a water unit.
11. If wind exceeds 15-20mph, there is heavy rain, or there is lightning the unit must be evacuated and turned off until weather subsides.
12. If there are any issues you most call the delivery driver or office immediately.
13. ADULT SUPERVISION REQUIERED AT ALL TIMES.



FINEES: Customer is responsible for returning unit in same condition it was received. We reserve the right to assess a fine of \$75 for each hour spent cleaning the unit. Customer is responsible for the cost of any physical damage up to and including cost of replacement. There ia a minimum fine of \$500 for silly String use.
